My Last "High"

I recently passed the two-year anniversary of my last bong hit, and it got me thinking back to the last time I smoked pot. Without a doubt, I finished at the bottom. Every character defect and every negative response to the drug was in full form that day, ensuring that if I ever think I could use a toke, all I have to do is think back to my last "high." It was, in fact, an extreme low.

It was Labor Day, 1999. I had been attending MA meetings for about six weeks but had less than 30 days clean, and I went back to my hometown of Memphis, Tennessee, for a visit. Problem was, there was no MA there, and I wasn't ready yet to branch out into other 12-Step programs for support.

My old pothead friends invited me over to their place for a cookout. There I was, beginning the process of getting sober, and I knew without question I would never make it through that cookout without getting loaded. I wasn't ready to tell my friends about being in recovery, and I was certainly incapable of saying no to actual marijuana.

So I decided to just have at it. Resistance was futile. I was powerless! I got there, grabbed a beer, and said, "So where's the herb?" I smoked up - the same rancid, brown, headache-causing garbage weed I had left behind when I moved to Oregon, home of the Kind Green Buds - and within moments I was pitifully stoned. And

there I was again, back at my bottom: paranoid, isolated, barely able to speak, surrounded by people I didn't really know, depressed, doing something I wished I wasn't doing, and unable to change any of it.

This didn't stop me from smoking more, of course. I smoked and drank all day, and then I drove home. Nor did it stop me, when I was left alone with the guy's stash, from stealing some of it to use later - at my parents' house. I was stealing the stuff that was making me miserable from people who were supposed to be my friends, then driving home plowed in a state where I already had a DUI on my record. My life was unmanageable!

I got home with my little stolen pocketful of depression, and I felt lower than a tech stock. I knew in my heart that I was utterly powerless against weed, that I needed to get it out of my life entirely and forever. Of course, I still had this stolen stash, so I did the only thing I could at the time.

Did you see this coming? That's right - I smoked it! I knocked back three or four bong hits in a row and thought, "There, I 'got rid' of it."

It was not long after this, when I got back to Oregon and to MA, and I started putting some clean days together, that some things I heard at my first meetings started to make sense to me. One was the simple power of "Keep coming back." Another was "I don't have to do that anymore." I clearly had no

choice in the matter on Labor Day 1999, because I was, as Life With Hope says, "ensnared in the insidious grip of marijuana."

But now I have found a power that's greater than my addiction. On Labor Day 2001 I went for a hike with sober friends and then went to a meeting and carried the message of hope and recovery. That, my friends, is progress!

Today I have a new high, a real high. I'm free of marijuana, and of the stealing, isolation, and paranoia I wallowed in during that last "high." I have true friends with whom to share a real life. My last "high" was a low bottom which today I can learn from and even laugh at, and that's a real blessing.
