



## A MA Pioneer's Story

I have been sober from all mind altering substances since May 16, 1987. I was living in Mar Vista, a part of Los Angeles, where I heard about this Marijuana Anonymous meeting near where I lived. It was being held in a psychologist's office, an office which held 4 chairs and a desk, really claustrophobic, and the psychologist was not an addict in any program. He just sensed that there were people who could use a 12 Step program for marijuana and he generously offered the office.

I was at the third meeting ever in LA, in the spring of 1987, was there for the fourth meeting in his office and it became obvious we needed more space immediately. That was the last meeting in his office. I helped find the space which was to be MA's home for the next several years. We called ourselves The Mar Vista Group. We met Tuesdays and Thursdays in a church meeting room and the group grew incredibly quickly. More meetings started to sprout as I was leaving California in mid-1989.

I do remember we felt we were special. We were not like NA or AA, we were potheads. At the time, I recall meetings of NA and AA in Los Angeles (I identify as a pothead and alcoholic or addict) and being a pothead was considered laughable, not a real problem. So I would shut up and listen to what the similarities were, rather than the differences.

Because I was a so called pioneer of MA, new people looked up to me and some thought I was their guru. Then I would go to AA and being with people with real time and real Experience Strength and Hope, and I

realized that at 9 months of sobriety, I was a newcomer. While it was an ego trip to have newbies look up to me, I knew that I knew very little.

At some point we tried to find if there were other groups out there. We did our research before internet, and therefore before

Google too. We found one group existed in New York, and another in Europe somewhere. We heard about a meeting in Orange County, California. We reached out to Orange County and that connection was really cool. They came up to our meetings and at least one of us made it down there too.

As I left Los Angeles in the summer of 1989, there was talk of a meeting of all the groups, and then I came to read in the Life With Hope book that this convening actually

Through Great Spirit's Grace, I am free from both this mental obsession and physical compulsion.

Through my experiences: I came to (and continue to) believe in a power greater than myself, which I call Great Spirit or simply Goddess.

Each new day I am continuously restored from the insanity of active addiction. In sobriety's grace and freedom, I continue each day, these next 12-24 hours, to turn my life and my will over to the tender, loving care of this Great Spirit.

I trust this spiritual Force to continue to guide me in my recovery.

May I be kind all of my affairs. May my words be gentle and loving. Through my shortcomings, as a human being, may I have the ability to pause and withhold my tongue, yet not compromise my authentic voice. 


