## **Humility Defined** by Loren N.

Humility is to know one's place. This applies to our relationship with God as well. The higher a person becomes spiritually, the more humble he becomes. As we get closer to God, we become more realistic about our own limitations, vulnerability and mortality. We internalize the reality that every human's position is tenable and only God is eternal. Anything else precludes room for God to fit in.

The biggest personalities are usually the most arrogant. Picture the scene: A movie star walks into a party- strutting, cocky, head raised. His mannerisms shout: "I am great and I don't need you or anybody else." The room is silent with awe. Charisma! This is actually counterfeit charisma.

In our own lives, it is "feeling slighted" that most often gets us into trouble. When I am treated with less honor than I feel I deserve, my self esteem is bruised. So I compensate by telling myself I'm really much better than that. With my ego falsely inflated, my sense of reality is distorted - leading to a new cycle of disappointment, resentment,

stress, anger and frustration. If I were more objective and realistic about my proper place, I would be spared all that hurt.

Because true humility means living with the reality that nothing matters except doing the right thing. The humble person is not dependent on the opinion of others. Because sometimes doing the right thing is popular (and consistent with one's ego needs), and sometimes it's not. But the humble person can set his ego aside, if need be, in order to consistently do the right thing.

An arrogant person, on the other hand, is not concerned about right and wrong - only about himself and how well things will turn out for him. He can appear to be smooth on the surface, but he's really just manipulating everything around him to suit his self-centered needs.

"Arrogance" = I'm all that counts.

"Humility" = What's greater than me is what counts.

In actuality, it is humility which guarantees charisma!

The humble person has the ability to rise above his self-contained narcissistic envelope and embrace those around him. Since he confidently knows his place, he can leave space for others without having an ego crisis. He honors others and helps them find their place, too. Isn't that true charisma?!

Humility is the ability to be objective about one's own position vis-a-vis everyone else. If I am in the position to lead, then I should lead. And if not, I should defer. I must know where I stand, and not take undo liberties. If I am in the presence of someone more knowledgeable, I should think twice before speaking.


## 1999 MAWS Conference

The Marijuana Anonymous World Service (MAWS) Conference was held in Portland, Oregon

Memorial Day Weekend. The following is a very brief synopsis of the issues, reports, and motions.

## 1999 MAWS Conference continued

District Reports: Delegates from all eleven established districts gave 5 - 7 minute reports of the past year in their respective areas. One district has begun ordering 15 day chips. Most districts noted trouble in generating interest in Hospitals and Institutions. (The committees that send small groups of recovering MA addicts to talk to patients or inmates in hospitals and institutions about their own personal stories.) Most districts were able to contribute money to MAWS this year, and many have had new meetings start up in the past year. Districts 3 and 9 (South Bay, CA and Santa Cruz, CA) have been busy preparing for Convention 2000 in January and District 1 (San Francisco) has already begun preparation to host Conference 2000 next May.

Trustee Reports: Policies and Procedures reported that Service Manual updates are

New available. Meeting good Outreach reported progress with our 29 orphan meetings (meetings outside of established districts). Treasurer reported that donations were down approximately \$6000 from last year and that more help will be given to district treasurers to help them submit timely and accurate reports. monthly Services reports growth with the Online Penpal Service, and a great interest for online meetings outside ones on AOL currently available.

A New Leaf Report: Asked that Bureau Chiefs of each district be more active in gathering stories for the Monthly newsletter. The editors have been having a very difficult time getting enough input for each issue.

Office Manger Report: Stepping down this month, but a new OM has been selected to start in June. Twenty new orphan meetings started over the last year. Reminded everyone that the International Directory is updated quarterly.

The Conference then broke into it's four committees: P&P (Policies and Procedures), Literature, Finance, and H&I/PI (Hospitals and Institutions/Public Information) for two long sessions of Committee meetings on Saturday and Sunday.

The General Session reconvened again later on Sunday afternoon and Monday morning.

Finance stressed the importance of timely district reports. It was noted many orphan meetings regularly donate to MAWS and that individual donations are also up.

H&I/PI recommended the creation of an online meeting format. Anyone interested in starting an online meeting outside of AOL should contact the

Literature approved Spanish translations of two more previously approved MA pamphlets which will be distributed when they are completed. The second edition of Life With Hope is still being worked on. A brief history of MA has been written for it and fifteen personal stories will be included.
