Just Stop Saying No by Jeff M.

I came into this program kicking and screaming, and I caught the disease of addiction in the meetings of MA. When I first got here I didn't have a drug problem, I just put my very well paying job, the well being of my family, my responsibilities, everything I had worked for, for the last 30 years on the line. For what, for a temporary short lived escape from reality? That sure sounds like a rational person to me. NOT!

It was not easy giving up my best friend, and as I have heard many people say, my lover. Even after a couple of years, it is not easy; simple yes, easy no. I had thought about quitting smoking pot even before I failed that drug test, because my life was spiraling out of control, but I didn't know how. Consequently, when I was forced into the program the first thing I did was shut-up and listen, because anything would be better than the mess my life had become. But remember I was still not an addict, I just wanted my life back, and under control.

After going to several meetings mandated by my hospital program, it happened. I heard someone leading a meeting tell my story. Sure there were differences, he had used a lot more

drugs than I had, he had fallen harder than I had, but it was the similarities that caught my attention. He had felt he wasn't an addict when he first got into the program. When he was forced into the program all he wanted to do was get his life back and under control. laughed and said that his life still wasn't under control, but now he accepts the fact that he is an addict. He accepts his life as is it today, because this is exactly where he is supposed to be. He went on to say that all of this, all of his serenity is because he learned to "Just Stop Saying No!" I just stopped saying No I am not an addict, because maybe, just maybe I was. I didn't say yes, I just stopped saying no. Just stop saying, "No there isn't a Higher Power," because maybe, just maybe, there is. You don't have to say yes there is, just stop saying no there isn't. You don't have to start having faith, you just have to stop having no faith.

All these thoughts and more were going through my head during the meeting. I was so distracted I didn't realize a birthday celebration was going on until the leader walked up to me and gave me his 2-year chip. Because of that chip, I made a

point to talk to him after the meeting to thank him. Because I thanked him we started talking, and we talked, and we talked. To this day, several years later, we continue to talk every day as any good sponsor and sponsee should.

Because I decided to shut up and listen, because I decided to just stop saying no, I wasn't an addict, no there wasn't a Higher Power. Because I decided that maybe, just maybe, I didn't have all the answers. Because I decided to have a little faith in myself and stop saying NO, my life has blossomed beyond my wildest dreams. The promises on page 84 and 85 of the big book have happened in my life seven fold, and ALL I had to do was just stop saying NO!

belittlement and neglect of me

The only problem was that home is wherever you set up camp for the night and I found unappreciative people wherever I went. I also, in all fairness, made sure that if someone thought I was cool, I either ignored them or proved that I was a jerk by over-reacting to circumstances, being overly sensitive to minor criticism or just having some kind of fit. It takes two to tango and I am multitudes. A veritable dance studio of mayhem and vitriol. Today things are different. I show up and talk about who I am. I am clean and sober today so that I can see things more clearly. So that I can see my own behavior more clearly. So that I can not fool myself or allow myself to engage in destructive behavior. I am fostering long lasting friendships by expressing my true feelings and by allowing others to share their feelings without blowing up or turning them away. So, I am learning. Learning from others who I am. Who I am with and in relation to them. Learning that they can love and appreciate me, with all my pimples and pudge, with my pedantic way and my black, nasty humor. I am finding out that I can be very lovable. It's very hard for me to get, but I am getting

ANLP directed that each District use these masters to make copies the pages available to the DSC, groups, and all members who possess Revision


