The Skinny on Merchandise

When I became an MA World Services Trustee, I wanted to help with the development of our own fund-raising merchandise. Up until now, we just weren't in a financial position to do anything with merchandising since you have to invest

some money before you can raise some money. We just didn't have much to invest. But that situation is changing. Merchandise can help support such things as the huge amount of new meeting packets being sent out each month to cities and countries all over the world. As our

fellowship grows so do the expenses of carrying the message of our existence and maintaining some sort of support network for all our new members on a global scale.

In the past, MAWS survived on a shoe string. In '95 we were broke. There was very little money for merchandise (What little we had produced had been "fronted" by individual members). A gross of T-shirts costs approximately \$700, and 300 mugs costs around \$900. Merchandise was obviously less important then the "800 Line" and the first printing of Life With Hope. After the first printing of our "12 & 12" and after District 7 hosted the very successful Second Annual Convention, finances turned around. It was finally time for merchandise. Since some T-shirts had been purchased already.

mugs were next on the agenda.

The mugs were produced and half of them were sold at the last World Services Conference. A few Districts bought mugs through their delegates and some were purchased by individual members. At present we have 140 new mugs

remaining, and 34 old "Life With Hope Logo" t-shirts and sweat-shirts. This is a small inventory of items. World Services has recently allocated \$1000 for new merchandise. A new T-shirt logo is being worked on and more ideas are welcomed. Soon, World Services T-shirts and stickers will be available to Districts to

be sold at their own events. Merchandise will also be available at events such as the World Services Convention.

Since the Seventh Tradition states "we are self supporting through our own contributions" we can only sell

merchandise to members of the fellowship. As the fellowship grows, the merchandise distribution system has to grow as well. As we put it into place, it is

important to uphold the Twelve Traditions and respect the autonomy of each district and meeting.

In the future, I envision an MA distribution hub on the MA "web-site" where a variety of items can be purchased by members.

Going to college, having a part-time job, and owning a brand new car... I felt I was a "normie". In my head, I assumed addicts were those that dropped out of college, got kicked out, or could not sustain a roof over their heads. In the end, though, my thinking has taken a 180 degree turn.

If you are new to the program and question whether or not you are an addict, ask yourself one question. "Would not using for 90 days be a conceivable idea?" Pot may not seem like an evil substance because it is so easy to function in life while using. You don't hear about people killing each other

over pot or having serious car wrecks over pot. However, the effects of it are strong and subtle.

I've been clean for about 17 months. I've found that I do not stay at home as much as before. I'm usually busy with an intensive job or out with my sober friends. Also, I have noticed that I feel emotions which before were numbed by marijuana.

My view on this chaotic world has changed from pessimism to one of optimism. While using pot, I felt that the end of the world ought to hurry up, because nothing seemed positive. All I ever did was hang out at home and watch TV. These days, on average, I view an hour per week, at most. My perspective on the world has changed. Now I feel that we, as a species, are evolving, day by day, into something better.

I'd like to end with a note for the newcomers. If you want it bad enough, you will find a power greater than yourself to stop using. That is the MA program.


