Living Life with Hope by Dr. Jon P.

The facts of my life are good. I am clean and sober, healthy, prosperous enough, well loved and with much to be grateful for. I am struck however by my acute inability to nurture myself with greater ease. When I reach a moment of despair, which I do almost daily, I fall ever more deeply into the pit.

I am reminded now, however, of a wonderful sermon that was delivered recently at my church. The pastor told the story of Joseph, whom as you may recall was taken first out to the desert to be killed by his envious brothers. You may recall also that Joseph was favored by his father who had made him a special coat. Well, as it turns out, the brothers decided that perhaps it might be more profitable to sell Joseph into slavery to the Egyptians. Thus they would thereby avoid the sin of fratricide and perhaps turn a good sum for their handsome brother in the bargain.

The focus of the sermon however was upon Joseph and his deep, personal and trusting relationship in the All Mighty. There he was at death's door, alone and abandoned in a pit into which he had been thrown by his faithless prothers. Without water, food, or means of escape he lay prisoner to await the long and terrible death that comes to all of us in the heat of the open desert.

But we remember Joseph for his steady hope and faith in his Creator. "There" reminded our pastor, "stood Joseph, in quiet and blessed assurance in the awesomely hopeful eyes of God." This thought has not left me. Sometimes I can hear my pastor words in the darkest moments:

"I stand in blessed assurance in the awesomely hopeful eyes of God."

But imperfect sinner that I remain, how far from these consoling words my soul does drift. But I am contained when the love of God fails me, as it so often does, by the love of others. "None of us is complete," I am also reminded by a Deacon friend of mine who shares in our Recovery.

When God is far and has turned his face away from his unworthy servant, it is to you, my friends, my sponsor, the program that I turn in my imperfections which no doubt shall continue so long as I remain in this finite life. Unlike Joseph, my faith is weak and my hope falters. It is at times like these that the fellowship of community and our collective struggle sustain me.

Thank you for continuing

with me down the ever more narrow road of Recovery. The further I go, the clearer it becomes, that it is also from the illusions of this life that I must recover. It is from my false expectations and anxiety ridden anticipations that I must continue to heal. But alas, I am still found wanting in both acceptance and surrender.

The Buddha was right to teach us that the cause of all human suffering is indeed desire. But the greater lesson that lay beneath this truth is lesson of Joseph: that we are none of us alone; that we are each of us connected; and that God's eyes, do indeed remain upon the sparrow as they looked that awful day upon Joseph. It is the same all seeing eyes of God, I am convinced, that do on this day watch over you and look upon me.

The lies, deception, and half-truths were staring me in the face. I was arrested and put into jail. That's where and when I hit my bottom. I prayed for the first time in months for forgiveness and a way out of my "privately defined world"...my addiction. I was released on my own recognizance and instructed to attend a 12 Step program.

It doesn't seem that long ago when I walked into an MA meeting. I had tried other programs that weren't for me before I heard about MA. I was still in denial about having a problem with marijuana and resentful that I was instructed

to attend. I immediately felt at home though and silently answered yes to the 12 Questions. That night I also met Victor K. who planted the seed in me. We talked after the meeting and I felt welcomed. With two simple phrases he got me hooked. He told me to "Keep Coming Back" and to "Take It One Day at a Time". So I kept coming back and began to do what was suggested. I got a sponsor and worked the 12 steps. Before completing my 4th step, I was in service. Currently I'm our District Coordinator **Events** and 2000 Convention Events Coordinator. It hasn't been easy, but it has been simple. Doing what others have done before me, I've put together a couple of years. Finding my

"Higher Power", spirituality, peace and serenity has been one hell of a ride.
